# LOCAL GOVERNMENT ACT 1993 PROCLAMATION

MARGARET BEAZLEY, Governor

I, the Honourable Margaret Beazley AC KC, Governor of the State of New South Wales, with the advice of the Executive Council and in pursuance of section 218B of the *Local Government Act 1993*, do, by this my Proclamation, alter the boundaries of the areas of-

- (a) Tamworth Regional as described by Proclamation in Government Gazette No. 69 of 10 June 2005, and
- (b) Liverpool Plains as described by Proclamation in Government Gazette No. 483 of 20 October 2023-

by transferring the land described in Schedule A from the Liverpool Plains local government area to the Tamworth Regional local government area so that the boundaries of the area of-

- (a) Tamworth Regional are the boundaries shown on the map kept in the register of public surveys and having the identifier number PP5254, and
- (b) Liverpool Plains are the boundaries shown on the map kept in the register of public surveys and having the identifier number PP5255.

I also make the provision in Schedule B for the apportionment of rates and charges between the councils of the said areas.

In this Proclamation *register of public surveys* means the register of that name kept under the *Surveying and Spatial Information Act 2002*.

This Proclamation commences on the day and at the time at which it is published in the Gazette.


