1 Name of Instrument

This Instrument is the *Fisheries Management (Fishing Determination – Red Sea Urchin) Notification 2023*.

2 Definitions

In this Instrument:

red sea urchin means fish of the species *Heliocidaris tuberculata*.

sea urchin and turban shell restricted fishery means the restricted fishery declared under Part 9, Division 1 of the *Fisheries Management (General) Regulation 2019*.

TAC determination has the same meaning as in section 40A of the Act.

TAF committee means the Total Allowable Fishing Committee.

the Act means the *Fisheries Management Act 1994*.

3 Notice of TAC determinations for red sea urchin

(1) The TAC determinations notified by this instrument have effect for the following periods:

(a) 1 January 2024 to 31 December 2024, and

(b) 1 January 2025 to 31 December 2025.

(2) For each fishing period specified in subclause (1) of this clause, the TAC determination for red sea urchin in the sea urchin and turban shell restricted fishery, as made by the TAF Committee under to section 40D of the Act and clause 134 of the *Fisheries Management (General) Regulation 2019*, is 9.5 tonnes.
