It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 49 — An Act to An Act to amend the *Electricity Infrastructure Investment Act 2020* in relation to the functions of the energy security target monitor and other matters; and to amend the *Energy and Utilities Administration Act 1987* in relation to the governance arrangements for the Energy Corporation. **[Energy Legislation Amendment Bill]** 

Act No. 50 — An Act to amend the Transport Administration Act 1988 to reorder the priorities of the objectives of the Transport Asset Holding Entity of New South Wales. **[Transport Administration Amendment (TAHE) Bill]** 

Act No. 51 — An Act to amend the Road Transport Act 2013 in relation to the automated detection of seatbelt offences; and for related purposes. [Road Transport Legislation Amendment (Automated Seatbelt Enforcement) Bill]

Act No. 52 — An Act to repeal the Greater Cities Commission Act 2022 and to amend the Environmental Planning and Assessment Act 1979 to abolish the Greater Cities Commission and transfer the strategic planning functions of the Greater Cities Commission to the Secretary of the Department in which that Act is administered; and for related purposes. [Greater Cities Commission Repeal Bill]

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 42 — An Act to amend the *Fire and Rescue NSW Act 1989, NSW Reconstruction Authority Act 2022, NSW Reconstruction Authority Regulation 2023, Rural Fires Act 1997* and *State Emergency and Rescue Management Act 1989* to make miscellaneous amendments. **[Emergency Services Legislation Amendment Bill]** 

Act No. 43 — An Act to amend the *Centennial Park and Moore Park Trust Act 1983* in relation to car parking in certain areas in Moore Park East. [Centennial Park and Moore Park Trust Amendment (Car Parking) Bill]

Act No. 46— An Act to amend the *Casino Control Act 1992* to clarify that certain actions do not give rise to any rights to compensation from the Crown; to authorise the Treasurer to enter into a jobs guarantee agreement with a casino operator; and for other purposes. **[Casino Control Amendment Bill]** 

Act No. 47— An Act to amend the *Crimes Act 1900* in relation to the prosecution of certain offences. **[Crimes Amendment (Prosecution of Certain Offences) Bill]**
