# EXTENSION OF THE PERIOD IN WHICH A BY-ELECTION IS TO BE HELD TO FILL A VACANCY IN CIVIC OFFICE ON LACHLAN SHIRE COUNCIL

I, the Hon. Wendy Tuckerman MP, Minister for Local Government, am of the opinion that it would be both impractical and inconvenient to hold a by-election within the time prescribed by section 292 of the *Local Government Act 1993* to fill the vacancy in civic office of Lachlan Shire Council (D Ward) occasioned by the failure of the by-election that was due to be held on 25 February 2023 to fill the vacancy created by the death of former Councillor Elaine Bendall.

Pursuant to section 293(1) of the Act, I appoint Saturday 20 May 2023 as the date on which the by-election is to be held.

#### **Explanatory Note:**

Section 318 of the Act provides that where a by-election to fill a vacancy in a civic office fails, another by-election must be held to fill the vacancy. The latter by-election must, by reason of section 292 of the Act, be held within 3 months of the failure of the earlier by-election. However, if the Minister is of the opinion that it would be impractical or inconvenient to hold the latter by-election within that 3 month period, section 293(1) of the Act authorises the Minister to appoint a later date for the holding of that by-election.
