Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to The University of New England to designate, advertise and recruit positions for Aboriginal and/or Torres Strait Islander persons only, in pursuance of its goal of a 3% Aboriginal and Torres Strait Islander workforce participation rate.

This exemption will remain in force for 3 years.

### EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act 1977* (NSW) to Sydney Opera House Trust Staff Agency to:

- offer professional development programs and initiatives to Aboriginal and Torres Strait Islander persons only; and
