I refer to my letter to you of 11 January 2024 in relation to the referral of the financial modelling of councils for IPART's investigation and report.

Under section 12A(4) of the Independent Pricing and Regulatory Tribunal Act 1992 (IPART Act), I hereby withdraw the referral I provided under section 12A of the IPART Act in my letter of 11 January 2024.

The reason this referral is being withdrawn is to avoid unnecessary duplication, as the matter will now instead be considered by the NSW Parliament's Standing Committee on State Development. The Committee will inquire into and report on the ability of local governments to fund infrastructure and services. The inquiry is scheduled to begin shortly, and it is anticipated that the Committee will report ahead of the Local Government elections, which are scheduled for 14 September 2024.

Under the provisions of section 126 of t*he Anti-Discrimination Act* 1977 (NSW), an exemption is given from sections 8 and 51 of the *Anti-Discrimination Act* 1977 (NSW) to Insurance Australia Group Limited (ACN 090 739 923) (IAG), Insurance Australia Group Services Pty Limited (ACN 008 435 201) (IAGS) and Insurance Manufacturers of Australia Pty Limited (004 208 084) (IMA) (collectively, IAG Group) to designate, advertise and recruit roles for Aboriginal and Torres Strait Islander persons in pursuance of a 3% workforce participation rate.

This exemption will remain in force up until 30 June 2028.

# **ASSETS FORFEITURE NOTICE**
