REGULATION OF VESSELS – REGULATED AREA AND SPECIAL RESTRICTIONS

Location

Murray River – near the township of Torrumbarry between the 1636km and 1648km river markers.

Duration

7:00am to 5:30pm on the following dates:

- Saturday 6 April 2024
- Sunday 7 April 2024

Detail

A fishing competition will be conducted on the navigable waters of the Murray River as specified above.

Due to the risk to safe navigation as a result of the large number of participating vessels, a Regulated Area will be created within which **Special Restrictions** will be imposed. The Regulated Area will comprise the full width of the Murray River between the locations detailed above.

The Regulated Area will be marked by buoys and monitored by control vessels stationed at the perimeter and at various stages along the River.

Special Restrictions

Pursuant to Section 12(3) of the Marine Safety Act 1998, Special Restrictions apply to the Regulated Area between the above times:

- Towing of persons is prohibited, and
- Minimal wash must be produced.

Penalties may apply (section 12(5) – Marine Safety Act 1998).

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Shellharbour Boat Harbour and adjoining waters of the Tasman Sea defined by:

- 1. The entrance of the Shellharbour Boat Harbour to,
- 2. The waters contained between the transit of the navigation leads for Shellharbour Boat Harbour and the southern shoreline of Cowrie Island, then
- 3. East to the location created by the transit of the Shellharbour Boat Harbour leads and the eastern extent of Cowrie Island at Shellharbour, then
- 4. To North Shellharbour beach and approximately 400m north of the Surf Club.

Duration

• 9.00am to 1.00pm – Sunday 7 April 2024

Detail

A swim event will be conducted on the navigable waters of Shellharbour Boat Harbour and the Tasman Sea as specified above.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (section 12(5) – Marine Safety Act 1998).

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Jetty Beach, Coffs Harbour.

Duration

6:00am to 1:00pm - Sunday 7 April 2024

Detail

An ocean swim event will be conducted from the shores of Jetty Beach, extending east on the navigable waters of Coffs Harbour for a distance of approximately 700 metres.

An **EXCLUSION ZONE** is specified during the event, which will be marked by buoys in the water and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).
