SCHEDULE 2

RESTRICTIONS AS TO USER

Without affecting the generality of any requirement imposed by the *Pipelines Act 1967* or *Pipelines Regulation 2023*, the owner or occupier of land over which there is an easement for pipeline must <u>not</u> within the easement, except with the prior consent in writing of the person in whom the easement is vested:

- (a) Excavate (including blasting), drill or dig.
- (b) Erect, place or permit to be erected or placed any building, structure (including fence posts), plant, apparatus or equipment, earthworks, utility services or other improvements whether permanent or temporary on, over or under the land.
- (c) Alter or disturb existing levels, contours or gradients.
- (d) Plant or cultivate any tree within 3 metres of the pipeline or any apparatus or works.
- (e) Place on or use any part of the servient tenement for the transport, carriage or support of any heavy object, vehicle or implement, which could in any way cause or be likely to cause damage to the pipeline.
- (f) Undertake any other activity that represents a danger to the pipeline or is a danger to the operation of the pipeline or its apparatus or works including signs, vent pipes and cathodic protection systems including anode beds and electrolysis test points.

GEOGRAPHICAL NAMES ACT 1966

Notice of proposal to amend address locality boundaries in Blue Mountains Local Government Area

PURSUANT to the provisions of Section 8 of the *Geographical Names Act 1966*, the Geographical Names Board hereby notifies that it proposes to amend and create address localities in the Blue Mountains National Park (reserve) as shown on map GNB 6107-2A.

CHARITABLE TRUSTS ACT 1993 NOTICE UNDER SECTION 15 CY PRES SCHEME RELATING TO THE JAN COPPLESON MEMORIAL PRIZE FOR CANCER MEDICINE

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The Jan Coppleson Memorial Prize (**the Prize**) was established by an *inter vivos* gift to the University of Sydney (**the University**) by Mrs Ann Yard (**Mrs Yard**) on 26 January 1984 to establish a prize of a minimum of \$500 per annum to be paid to the University Faculty of Medicine as a capital sum each year during Mrs Yard's lifetime. The gift letter indicated that provision would be made to Mrs Yard's will for *inter alia* a bequest of the sum of \$25,000 to enable the income therefrom to be used towards the continuation of the Prize after her death. As at 25 September 2022, the Prize was valued at \$64,848.00.

Under the terms of the gift, the Prize was to be awarded annually to an undergraduate person who is the most proficient in final year in cancer medicine as judged by the results in the final exams for that year. The Sydney Medical School has existed since 1856 and forms part of the Faculty of Medicine and Health at the University. In 2014, the University replaced the undergraduate Bachelor of Medicine and Bachelor of Surgery (MBBS) with a postgraduate degree of Doctor of Medicine. The last cohort of MBBS was in 2013. As the undergraduate MBBS is no longer offered at the University, the original terms of the trust have become impossible to fulfil.

The University holds the gift from Mrs Yard on an express trust for the purpose of awarding a prize. Trusts for the establishment and award of prizes or scholarships for students at educational institutions or for study in a recognised field, such as medicine, are charitable as they fall within the charitable head of advancement of education.

As the University now offers medicine at a postgraduate level, a cy pres scheme is required to remove the requirement that the Prize recipient must be enrolled in an undergraduate degree, studying cancer medicine in their final year at the University. The proposed scheme would instead award the Prize to a student in medicine at the University who is most proficient in cancer medicine. While the proposed scheme removes the mechanism through which the Prize was to be awarded, by removing the requirement that the student's proficiency in cancer medicine be 'judged by the results of their final exams for that year', the University will determine the award of the Prize based on the University's scholarship and prizes policy current at the time the Prize is to be awarded. The Prize will continue to be styled or named the 'Jan Coppleson Memorial Prize for Cancer Medicine'.

As the Prize was intended to benefit medical students studying cancer medicine at the University, to commemorate Mrs Yard's late daughter, Jan Coppleson, the proposed new trust is sufficiently close to the original purpose of the trust.

In these circumstances, the Solicitor General, as the Attorney General's delegate, has approved the establishment of a cy pres scheme to alter the original purposes of the charitable trust so as to enable the Prize to be awarded to a student of medicine at the University who is most proficient in cancer medicine.

Take note that within one month after the publication of this notice any person may make representations or suggestions to the Attorney General in respect of the proposed scheme.

Part 1 Preliminary

1 Name of Order

This order is for the Rank Structure of the NSW Sheriff's Office.

2 Commencement

This order commences on the day on which it is published in the NSW Government Gazette.

3 Definitions

In this Order:

the Act means the Sheriff Act 2005 (NSW)

Part 2 Ranks of the NSW Sheriff's Office

4 Commissioned and Non-Commissioned Ranks

The distinction between Commissioned and Non-Commissioned Ranks are as follows:

- (a) All Sheriff's Officers serving in ranks listed in *Schedule 1 Commissioned Officers* may be vested with a Commission by the Governor of NSW, upon advice of the Sheriff.
- (b) All Sheriff's Officers serving in ranks listed in *Schedule 2 Non-Commissioned Officers* are not to be granted a commission unless or until they acquire a rank listed in *Schedule 1* (be that by promotion or by appointment).
- (c)All Sheriff's Office employees working in the Sheriff's Operations Centre (SOC) will be assigned as either commissioned or non-commissioned officers as described in the table in *Schedule 3 Sheriff's Operations Centre*.

Note: The above only concerns substantive positions. Persons acting in the role of a person of a rank listed in Schedule 1 on a temporary basis are not required to be granted a commission.

5 Requirements for attainment of a given rank

The Sheriff reserves the right to impose whatever policy, procedure, or requirement for persons to attain a rank and thereby a Commission. This may include educational requirements, meeting of key performance criteria or any other requirement such as good conduct.

6 Grant of Commission

Only Sheriff's Officers recommended for a Commission by the Sheriff are to receive a commission. This recommendation is to be consistent with the ranks listed in grant of a rank listed in Schedule 1.

7 Certificate of Appointment

All Non-Commissioned Officers, apart from Senior Sergeants and Sergeants (Schedule 2 [1] and [2]) are to receive a 'Certificate of Appointment' by the Sheriff.

8 Warrant of Appointment

All Sergeants and Senior Sergeants are Senior Non-Commissioned Officers and are to receive a 'Warrant of Appointment'. This is to be issued by the Sheriff.

9 Revocation of a Commission

The Sheriff reserves the right to recommend that the Governor revoke a Commission in the event of a finding of misconduct or unsatisfactory performance. This does not affect any other disciplinary powers the NSW Sheriff's Office may use under the *Government Sector Employment Act 2013* (NSW) or any other law.

- 2. Sergeant,
- 3. Leading Senior Sheriff's Officer,
- 4. Senior Sheriff's Officer,
- 5. Sheriff's Officer,
- 6. Probationary Sheriff's Officer,

Schedule 3 – Sheriff's Operations Centre

A Sheriff's Officer who is assigned to duties within the Sheriff's Operations Centre, will be afforded a specialist Sheriff's Operations Centre rank equivalent to their existing rank. This rank equivalency is provided within the table below:
