ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 3 April 2024

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of His Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 14 — An Act to amend the *Ageing and Disability Commissioner Act 2019* to implement a number of recommendations arising from an independent statutory review of the Act; and for other purposes. **[Ageing and Disability Commissioner Amendment Bill 2024]**

Act No. 15 — An Act to amend the *Children and Young Persons (Care and Protection) Act 1998* in relation to the extraterritorial application of the Act to children and young persons outside of New South Wales. **[Children and Young Persons (Care and Protection) Amendment Bill 2024]**

Act No. 16 — An Act to amend the *Combat Sports Act 2013* and the *Combat Sports Regulation 2014* for particular purposes. **[Combat Sports Amendment Bill 2024]**

Act No. 17 — An Act to make miscellaneous amendments to the *Independent Commission Against Corruption Act 1988*. **[Independent Commission Against Corruption Amendment Bill 2024]**

Act No. 18 — An Act to amend the *Bail Act 2013* to provide for a temporary limitation on granting bail for certain young persons in relation to certain serious offences; to amend the *Crimes Act 1900* to provide for a new offence in relation to performance crimes; and to make consequential amendments to the *Criminal Procedure Act 1986*. **[Bail and Crimes Amendment Bill 2024]**

Act No. 19 — An Act to ban practices directed to changing or suppressing the sexual orientation or gender identity of individuals, including by creating offences and a civil complaints scheme in relation to the practices; and for related purposes. **[Conversion Practices Ban Bill 2024]**

Act No. 20 — An Act to amend certain legislation administered by the Minister for Climate Change and the Minister for the Environment to provide for strengthened regulation, and increased penalties for offences, relating to the protection of the environment; and to amend the *Land and Environment Court Act 1979* for related purposes. **[Environment Protection Legislation Amendment (Stronger Regulation and Penalties) Bill 2024]**
