#### MARINE NOTICE

#### **REGULATION OF VESSELS – SPECIAL RESTRICTIONS**

#### Location

Hawkesbury River – Spencer to Windsor.

#### **Duration**

From 12:00pm Monday 8 April 2024, to 5:00pm Monday 15 April 2024.

#### **Detail**

Due to the recent flooding of tributaries into the Hawkesbury River, significant navigation hazards including trees, shallowing or other debris may exist. As such, **Special Restrictions** will be imposed at the location specified above.

Vessel operators are advised to exercise extreme caution when navigating in these waterways including monitoring the available depth of water.

### **Special Restrictions**

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, Special Restrictions apply to the above area between the above times:

- Speed limit of 15 knots, and
- Towing of persons prohibited.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).
