1 Name of notice

This notice is the *Coal Market Price Emergency (Directions for Power Stations) Amendment Notice April 2024.*

2 Commencement

This notice commences on the day on which it is made.

3 Amendment of Coal Market Price Emergency (Directions for Power Stations) Notice 2023 No. 2

The Coal Market Price Emergency (Directions for Power Stations) Notice 2023 No. 2 is amended in accordance with Schedule 1 of this notice.

4 Interpretation

Terms in this notice have the same meaning as defined terms in the-

- (a) Coal Market Price Emergency (Directions for Coal Mines) Notice 2023 No. 2, and
- (b) Coal Market Price Emergency (Directions for Power Stations) Notice 2023 No. 2.

Schedule 1 - Amendment of Coal Market Price Emergency (Directions for Power Stations) Notice 2023 No. 2

[1] Insert after section 9—

9A Direction about exception from maintaining a stockpile of coal, entering coal supply agreements and giving information to coal suppliers

- (1) Notwithstanding section 5 or any other section— sections 7, 8 and 9 do not apply to a *specified relevant person* in regard to a coal supply agreement that—
 - (a) is entered into after the commencement of the *Coal Market Price Emergency* (*Directions for Power Stations*) *Amendment Notice April 2024*, and
 - (b) provides for coal to be delivered from the specified coal supplier to the specified relevant person by any means except rail, and
 - (c) provides the coal is to be delivered only after the specified relevant person has notified the specified coal supplier in writing that it has a stockpile of coal that will meet the expected demand of the specified relevant person up to and including 30 June 2024.
- (2) In this section—

specified coal supplier means-

- (a) Centennial Mandalong Pty Limited ACN 101 508 892 (ABN 74 101 508 892), or
- (b) Centennial Myuna Pty Limited ACN 101 508 981 (ABN 95 101 508 981).

specified relevant person means Origin Energy Eraring Pty Ltd ACN 164 994 012 (ABN 31 357 688 069).
