REGULATION OF VESSELS – EXCLUSION ZONE

Location

Wagonga Inlet, Narooma – within a 200-metre radius from a barge positioned approximately 300 metres west of the landmark of Quota Park and midway between Shell Point and Lavender Point.

Duration

• 6:00pm to 11:00pm – Friday 3 May 2024

Detail

A fireworks display will be conducted over the navigable waters of Wagonga Inlet, Narooma as specified above, and involve the use of a stationary barge as a launch platform. The area directly around the barge may be dangerous and hazardous while fireworks are being launched.

An **EXCLUSION ZONE** is specified during the event which will be monitored and maintained by event staff and control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Manning River between the Martin Bridge at Taree, along the Manning River South Passage, to Harrington.

Duration

8:00am to 5:00pm on the following dates:

- Saturday 27 April 2024
- Sunday 28 April 2024

Detail

Competitive water ski races will be conducted on the navigable waters of the Manning River at the location specified above, involving the use of high-speed power vessels, persons being towed at speed using towlines, and persons in the water from time to time presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event which will be marked by the presence of support vessels on the perimeters.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone which will be monitored by control vessels, during the above times.

Transiting Vessels

Provision has been made for vessels to transit the Exclusion Zone during breaks in racing. Control vessels (via race control vessels and control points on shore) will, at times during the events, authorise local vessel traffic to transit the Exclusion Zone.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).


Roads Act 1993 Notification of Road Closure

REGULATION OF VESSELS - EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Hastings River – near the locality of Port Macquarie as follows:

- Ironman Practice Swims between the Marine Rescue boat ramp and the downstream side of the Park Street Road bridge adjacent to the Broadwater Main Canal
- Ironman Races between the Marine Rescue boat ramp and the Broadwater Main Canal.

Duration

- 6:00am to 9:00am Friday 3 May to Saturday 4 May 2024 (Ironman Practice Swims)
- 6:00am to 11:30am Sunday 5 May 2024 (Ironman Races)

Detail

Ironman Practice Swims and the Ironman Races will be conducted on the Hastings River during the above times and at the locations specified above.

An **EXCLUSION ZONE** is specified during the events, which will be monitored by control vessels at the above locations. The exclusion zone will be indicated by the presence of control vessels on the perimeter of the zones.

Unauthorised vessels are strictly prohibited from entering the Exclusion Zone during the above times.

Transit Lane

Provision may be made (where necessary) for a control vessel to authorise local vessel traffic to pass safely through the course via a 'transit lane'.

Special Restrictions

Pursuant to Section 12(3) of the *Marine Safety Act 1998,* all vessels navigating the transit lane must do so at a speed not exceeding 4 knots and must produce minimal wash.

Penalties may apply (Section 12(5) – Marine Safety Act 1998).

Sections 46 and 47
