REGULATION OF VESSELS – EXCLUSION ZONE

Location

Coral Sea, Byron Bay – Wategos Beach to Main Beach.

Duration

- 9:00am to 12:00pm – Sunday 5 May 2024

Detail

A coastal swim event will be conducted on the navigable waters of Byron Bay, as specified above. The event course will be established from Wategos Beach extending North-Westerly, for a distance of approximately 2000-metres, finishing at the Byron Bay Surf Lifesaving Club.

An **EXCLUSION ZONE** is specified during the event at the location detailed above. The Exclusion Zone will be indicated by high visibility buoys, the presence of support vessels managing the event, and Maritime patrol vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone during the times above.

Penalties may apply (Section 12(5) – *Marine Safety Act 1998*).
