# Anti-Discrimination Act 1977

## EXEMPTION ORDER

Under the provisions of section 126 of the *Anti-Discrimination Act 1977* (NSW), an exemption is given from sections 8, 10, 19, and 51 of the *Anti-Discrimination Act 1977* (NSW) to the Walkley Foundation to advertise, facilitate and designate one scholarship per year for Aboriginal and/or Torres Strait Islander people only for its Indigenous Scholarship.

This exemption will remain in force for 10 years.
