# STATUTORY AND OTHER OFFICES REMUNERATION ACT 1975

## ERRATUM

---

The notice published in NSW Government Gazette No 152, notice number n2024-0740 of 26 April 2024, Report and Determination of the *Statutory and Other Offices Remuneration Act 1975* – President, Vice President, Deputy Presidents and Acting Judge of the Industrial Relations Commission, contained errors in paragraphs 1 and 4 and in the first sentence under the heading, Determination. This notice corrects the errors.

Paragraph 1: delete *Statutory and Other Offices Remuneration Tribunal Act 1975* and replace with *Statutory and Other Offices Remuneration Act 1975*.

Paragraph 4: Delete paragraph 4 and replace with:

Section 147 of the IR Act will provide that the offices of the President, Vice-President and Deputy Presidents of the IRC are referred to as Presidential Members. Section 149 will provide that those Members may be appointed as a member of the Commission in Court Session, which is to be known as the Industrial Court of New South Wales: s151A.

Under the heading Determination, delete Public Office Holders, and replace with Judges and Magistrates Group.

The gazettal date remains 26 April 2024.
