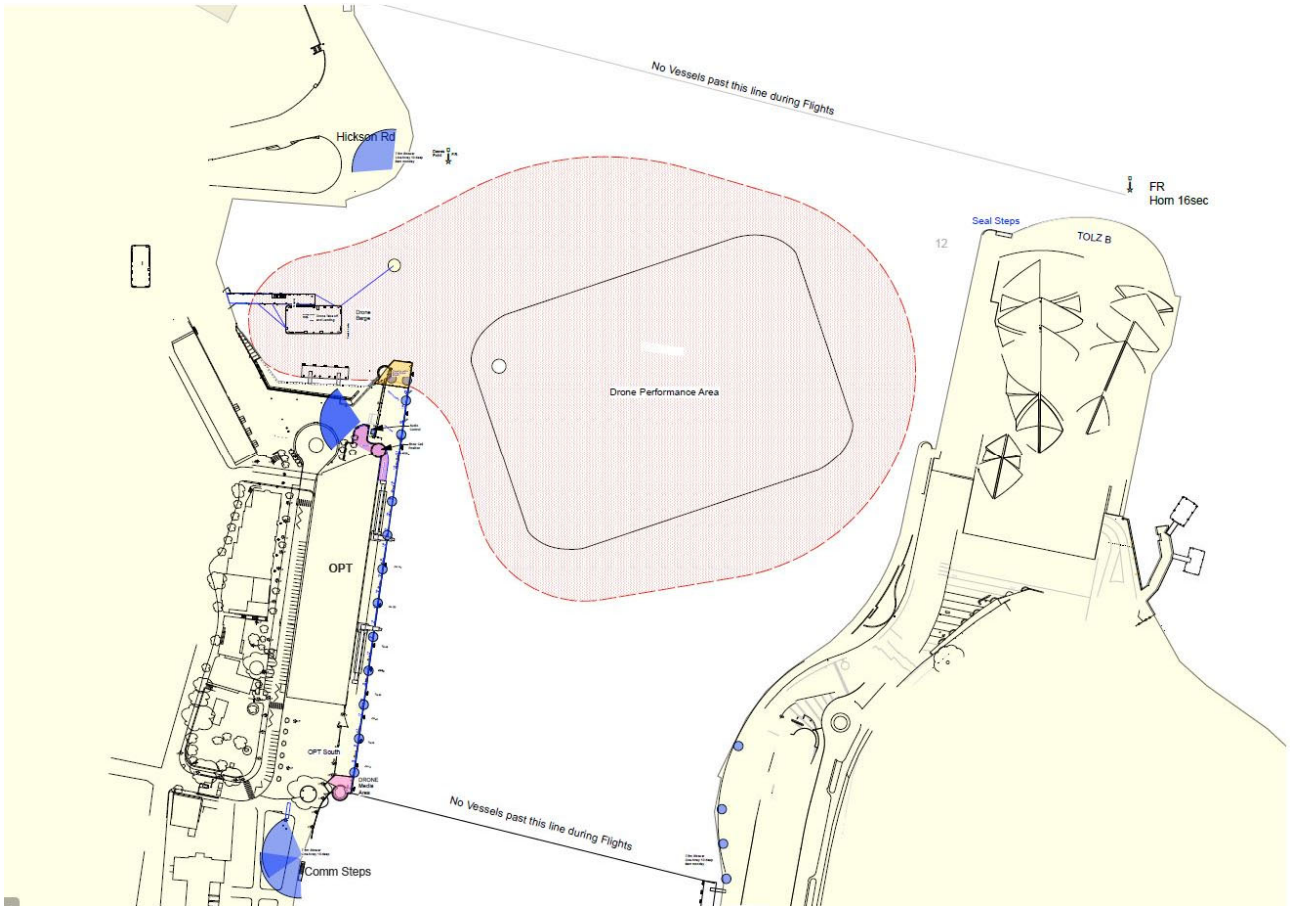

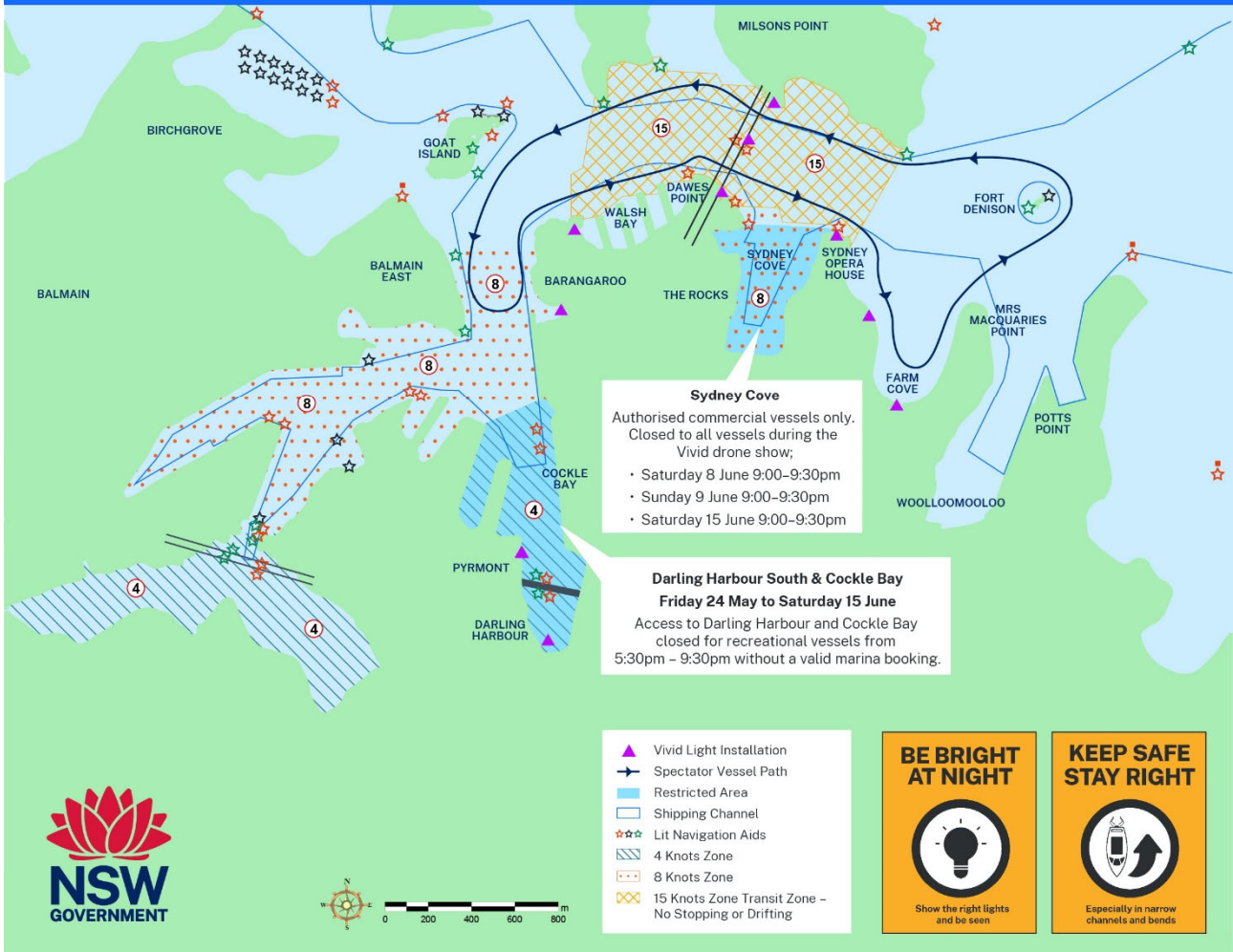

## ROAD TRANSPORT ACT 2013 – ORDER

The Honorable Margaret Beazley AC KC, Governor.

I, the Honorable Margaret Beazley AC KC, Governor of the State of New South Wales, with the advice of the Executive Council, and pursuant to the *Road Transport Act 2013* (the Act), do, by this Order, approve the type of traffic enforcement device named in Schedule 1 as being designed for photographing a driver or passenger in a vehicle who is not wearing a seatbelt in compliance with the statutory rules, in accordance with section 134(1)(i) of the Act.
