Restoration of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* a direction has been issued that the Order that took effect on and from 12 July 2019, on **Dr Glorina Susanto (MED0001137668)** of Bexley North NSW 2207, prohibiting her as a medical practitioner, from supplying, having possession of or issuing a prescription for a drug of addiction as authorised by clauses 101 and 77 of the Regulation, shall cease to operate on and from 04 June 2024.

Withdrawal of Drug Authority
