Explanatory note

The object of this rule is to amend the NSW Admission Board Rules 2015 to make a failure to complete the Board's examination within ten years as a 'failure to progress' issue that will exclude a student-at-law from sitting further of the Board's examinations, subject to their being permitted to apply for relaxation of that rule.

1 Name of Rule

This Rule is the NSW Admission Board Fifth Amendment Rule 2024.

2 Commencement

This Rule commences 1 July 2024.

3 Amendment of NSW Admission Board Rules 2015

(1) Rule 66A– Progression rule

Insert after Rule 66 the following:

66A

- (1) Subject to rule 67, a candidate who has not completed the examinations prescribed in rule 53 within 10 years of enrolling in their first subject shall be excluded from taking any further examination prescribed by these Rules.
- (2) Rule 67 (3) Relaxation of exclusion rues

Omit the sub-rule. Insert instead, including Note:

(3) The Executive Officer may, in circumstances which he or she regards as sufficiently special and upon such conditions as he or she things fit, relax rule 64, rule 65, rule 66 or rule 66A.

CHARITABLE TRUSTS ACT 1993 ORDER UNDER SECTION 12 CY PRES SCHEME RELATING TO J.T WILSON MEMORIAL PRIZE FOR ANATOMY

Section 12(1)(a) of the *Charitable Trusts Act 1993* (**the Act**) permits the Attorney General to establish a cy pres scheme to alter the original purpose of a charitable trust. Section 9(1) permits the application of trust property cy pres where the spirit of the original trust can no longer be implemented.

The J.T Wilson Memorial Prize (**the Prize**) was established in 1949 when the University of Sydney (**the University**) received a gift from the trustees of the J.T Wilson Memorial Fund. A condition of the gift was that the Prize be awarded annually to an undergraduate in their second year of Medicine who has, in the opinion of the examiners, most distinguished himself/herself in the subject of anatomy. The Prize is currently valued at \$11,209.

The University holds the gift on an express trust for the purpose of awarding a Prize. Trusts for the establishment and award of scholarships or prizes for students at educational institutions or for study in a recognised field, such as medicine, are charitable as they fall within the charitable head of advancement of education.

In 2014, the University replaced the undergraduate Bachelor Degree of Medicine and Bachelor Surgery with a postgraduate degree of Doctor of Medicine. As there is no longer discrete anatomy courses as part of the postgraduate medicine degree, it is no longer possible to award the Prize on the basis of the results in annual examinations in the subject of anatomy.

Having regard to the spirit of the trust, the University, in its capacity as trustee, seeks the establishment of a cy press scheme to enable it to award the Prize to a student studying medicine who most distinguishes himself/herself in the area of study of anatomy. The condition that the Prize would be awarded to a student who has shown sufficient merit would continue.

The proposed scheme will allow the trust to operate as closely as possible to the original gift conditions as the focus of the Prize will remain to benefit medical students studying at the University, in addition to commemorating Dr James Thomas Wilson and his work in anatomy.

In these circumstances, I, as the Attorney General's delegate, have approved the establishment of a cy pres scheme to alter the original purposes of the charitable trust so as to enable the Prize to be awarded to a student studying medicine who most distinguishes himself/herself in the area of study of anatomy.

Pursuant to section 12 of the Act, I hereby order that a cy pres scheme be established whereby the original purposes of the charitable trust known as the J.T Wilson Memorial Prize be altered so as to enable to Prize to be awarded to a medical student at the

University who has distinguished himself or herself in the study of anatomy, provided they have shown sufficient merit.

The order will take effect 21 days after its publication in the NSW Government Gazette, in accordance with section 16(2) of the Act.

SUBORDINATE LEGISLATION ACT 1989

Surveying and Spatial Information Regulation 2024

Invitation to comment

The Surveying and Spatial Information Regulation 2017 will be automatically repealed on 1 September 2024, pursuant to section 10(2) of the Subordinate Legislation Act 1989. It is proposed to make a new Regulation, the Surveying and Spatial Information Regulation 2024, to operate from that date.

The proposed Regulation makes a number of changes to the provisions of the current Regulation. The proposed Regulation sets the standards for surveying of the cadastral boundaries that comprise the State cadastre, surveying of the networks that comprise the State control survey and other public surveys. The standards relate to the accuracy of measurements, the calibration of equipment, connection to state legislated datums, the marking of surveys, the preparation of the plan of survey and administration of registered surveyors.

A Regulatory Impact Statement, a draft of the Regulation and an index that compares the clause numbers from 2017 to the section numbers in the 2024 Regulation have been prepared and copies of them can be obtained from the NSW Government "Have Your Say" website at www.haveyoursay.nsw.gov.au or
