MENTAL HEALTH ACT 2007 Section 109 Declaration of Mental Health Facility

- I, AMY WYNDHAM, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, DO HEREBY:
- a) DECLARE the **Rupertswood Building**, Building 65, Mount Druitt Hospital campus, 75 Railway Street, Mount Druitt NSW 2770, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*; and
- b) DECLARE this facility to be designated in the "community or health care agency" class of facilities; and
- c) RESTRICT this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders, under the following provisions of the *Mental Health Act 2007*:
 - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
 - ii. Chapter 4; and
 - iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).

POISONS AND THERAPEUTIC GOODS REGULATION 2008

ORDER

Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* an Order has been made on **Dr Graeme Ronald Scheman (MED0001166435)**, of Thornton NSW 2322, prohibiting him until further notice, as a medical practitioner, from supplying or having possession of drugs of addiction as authorised by clause 101 of the Regulation and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation.

This Order is to take effect on and from 21 June 2024.
