

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Hunter River – between Stockton South Boat Ramp and Little Park Beach, Stockton.

Duration

6.30am to 11.00am on the following dates:

- Saturday 3 February 2024
- Sunday 4 February 2024

Detail

A number of swim events will be conducted on the navigable waters of the Hunter River as specified above (see the attached map).

An **EXCLUSION ZONE** is specified during the events, which will be indicated by control vessels stationed around the swimmers.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (Section 12(5) - Marine Safety Act 1998).

REGULATION OF VESSELS - EXCLUSION ZONE

Location

Wyangala Dam – adjacent to Wyangala Waters Holiday and Recreation Park.

Duration

8.00am to 6.00pm on the following dates:

- Saturday 3 February 2024
- Sunday 4 February 2024

Detail

A number of water-skiing races will be conducted on the navigable waters of Wyangala Dam as specified above. The event will involve the use of powered vessels and persons being towed at speed, with the possibility of persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be marked by inflatable buoys and monitored by control vessels stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998).
