REGULATION OF VESSELS - SPECIAL RESTRICTIONS

Location

Murray River – near Albury, between the Hume Dam Wall (downstream) to Noreuil Park.

Duration

- 2.00pm to 8.00pm Saturday 10 February 2024
- 9.00am to 3.00pm Sunday 11 February 2024

Detail

A canoe and kayak event will be conducted on the navigable waters of the Murray River as specified above.

Due to the risk to safe navigation and the nature and number of participating vessels, a Regulated Area will be created at the above times within which **Special Restrictions** will be imposed. The Regulated Area will comprise the entire width of the Murray River, and will extend 200 metres ahead and 200 metres to the stern of the competing vessels.

Special Restrictions

Pursuant to Section 12(3) of the *Marine Safety Act 1998*, **powered vessels** operating in the Regulated Area:

- Must not exceed the maximum speed limit of 4 knots, and
- Must produce minimal wash.

Penalties may apply (section 12(5) – Marine Safety Act 1998).

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Murray River – Entire width of the River at the following locations:

- Saturday 10 February 2024 Murray River between Perricoota Marina (at the 1690km marker) and upstream to the Victoria Park Boat Ramp, Echuca (at the 1712km marker); and
- Sunday 11 February 2024 Murray River between Torrumbarry Weir (at the 1630km river) and upstream to the Victoria Park Boat Ramp, Echuca (at the 1712km marker).

Duration

6.00am to 6.00pm on the following dates:

- Saturday 10 February 2024
- Sunday 11 February 2024

Detail

Competitive water ski racing will be conducted on the navigable waters of the Murray River as specified above. The event will involve the use of high-speed power vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the full width of the Murray River between the locations detailed on the respective days above. The Zone will be marked at each end by the presence of patrol and control vessels. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) – Marine Safety Act 1998).

6.00am to 6.00pm on the following dates:

Detail

The swimming leg of a triathlon will be conducted on the navigable waters of Trial Bay specified above.

An **EXCLUSION ZONE** is specified during the event, which will be marked by a series of buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) – Marine Safety Act 1998).
