MENTAL HEALTH ACT 2007 Section 109 Variation of Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- 1) **VARY** the Order published in the NSW Government Gazette No. 169 of 16 November 2007 page 8562 declaring certain premises to be declared mental health facilities by deleting the entry "Coffs Harbour District Hospital Outpatients Service", and its corresponding address of "Coffs Harbour Health Campus, Pacific Highway, Coffs Harbour NSW 2450."
- 2) **DECLARE** the **Coffs Harbour Community Mental Health Service**, Coffs Harbour Health Campus, 345 Pacific Highway, Coffs Harbour NSW 2450 to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*, and
- 3) **DECLARE** this facility to be designated in the **"community or health care agency"** class; and
- 4) **RESTRICT** this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders under the following provisions of the Mental Health Act 2007:
 - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
 - ii. Chapter 4; and
 - iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).

MENTAL HEALTH ACT 2007 Section 109 Variation of Declaration of Mental Health Facility

- I, DR BRENDAN FLYNN, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:
- 1) **VARY** the Order published in the NSW Government Gazette No. 169 of 16 November 2007 page 8562 declaring certain premises to be declared mental health facilities by deleting the entry "Kempsey Mental Health Service,", and its corresponding address of "119 River Road, Kempsey NSW 2440."
- 2) **DECLARE** the **Kempsey Community Mental Health Service**, 119 River Street, Kempsey NSW 2440, to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*, and
- 3) **DECLARE** this facility to be designated in the "community or health care agency" class; and
- 4) **RESTRICT** this facility to the provision of services and performance of functions necessary for, or associated with, the administration or management of community treatment orders, under the following provisions of the *Mental Health Act 2007*:
 - i. Part 3 of Chapter 3 (except for sections 61, 61A, 62 and 63);
 - ii. Chapter 4; and
 - iii. Chapter 5 (except for sections 111 and 112 and Division 2 of Part 2).

POISONS AND THERAPEUTIC GOODS REGULATION 2008

ORDER

Withdrawal of Drug Authority

In accordance with the provisions of clause 175(1) of the *Poisons and Therapeutic Goods Regulation 2008* an Order has been made on **Dr Mohammad Nizam Uddin (MED0001192373)**, of BERALA NSW 2141, prohibiting him until further notice, as a medical practitioner, from supplying or having possession of drugs of addiction as authorised by clause 101 of the Regulation and issuing a prescription for a drug of addiction as authorised by clause 77 of the Regulation.

This Order is to take effect on and from 22 February 2024.
