## Part 1 Preliminary

### 1 Name of Notification

This notification is the *Fisheries Management (Eastern Blue Groper Fishing Closure) Notification 2024*.

### 2 Commencement and duration

This notification commences on 1 March 2024 and will remain in force for one calendar year.

### 3 Definitions

In this notification:

*Eastern Blue Groper* means the species of fish *Achoerodus viridis*.

*recreational fisher* means a fisher who takes fish by any method, otherwise than for sale but does not include an Aboriginal person carrying out Aboriginal cultural fishing.

*Aboriginal cultural fishing* means fishing activities and practices carried out by Aboriginal persons for the purpose of satisfying their personal, domestic or

communal needs, or for educational, ceremonial or other traditional purposes, and which do not have a commercial purpose.

***Aboriginal person*** means a person who—

- (a) is a member of the Aboriginal race of Australia, and
- (b) identifies as an Aboriginal person, and
- (c) is accepted by the Aboriginal community as an Aboriginal person.

## **Part 2 Fishing closure**

### **4 Fishing closure**

A recreational fisher must not take Eastern Blue Groper.

## Part 1 Preliminary

### 1 Name of order

This order is the *Fisheries Management (Eastern Blue Groper Possession Limit) Order 2024*.

### 2 Commencement and duration

This order commences on 1 March 2024 and will remain in force for one calendar year.

### 3 Definitions

In this order:

***Eastern Blue Groper*** means the species of fish *Achoerodus viridis*.

***possession limit*** has the meaning in section 17A(2) of the Act.

***recreational fisher*** means a fisher who takes fish by any method, otherwise than for sale but does not include an Aboriginal person carrying out Aboriginal cultural fishing.

***Aboriginal cultural fishing*** means fishing activities and practices carried out by Aboriginal persons for the purpose of satisfying their personal, domestic or

communal needs, or for educational, ceremonial or other traditional purposes, and which do not have a commercial purpose.

**Aboriginal person** means a person who—

- (a) is a member of the Aboriginal race of Australia, and
- (b) identifies as an Aboriginal person, and
- (c) is accepted by the Aboriginal community as an Aboriginal person.

## **Part 2 Possession limits**

### **4 Recreational possession limit**

The possession limit for a recreational fisher in all circumstances is 0 for Eastern Blue Groper *Achoerodus viridis*.
