Detail

Circuit power boat races will be conducted on the navigable waters of the Hawkesbury River as specified above. A number of high-speed power vessels will be active in the area during the above times, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event at the location (see the attached map) which will be marked by buoys and monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Penalties may apply (section 12(5) – Marine Safety Act 1998).



Location

Budgewoi Lake – Budgewoi in a triangular space contained within the area from Goorarabah Point, Buff Point and to the NSW Marine Rescue Clubhouse (formerly known as the Toukley Aquatic Club).

Duration

9.00am to 5.00pm on the following dates:

- Saturday 20 and Sunday 21 January 2024
- Saturday 24 and Sunday 25 February 2024
- Saturday 13 and Sunday 14 April 2024
- Saturday 18 and Sunday 19 May 2024

Detail

Competitive high speed water ski races will be held on Budgewoi Lake at the location specified above. Persons will be towed at speed using tow-lines with the possibility of persons in the water from time to time presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during each event at the relevant location (see the attached map) which will be marked by buoys. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.

Provision has been made for vessels to transit the Zone during breaks in the racing. Control vessels will, at times during the event, authorise local vessel traffic to transit the Zone.
